#### ADMINISTRATIVE AGENDA

Mayor Morris mentioned that the Gillen Street extension should be completed within about a week and a half. Due to the depth and complexity of it, Benkendorf's will finish it because it is too deep for DPW. It is required that a representative from Maser Engineering will come and observe at times in order to make sure all is done at the appropriated angles and correctly.

More sidewalk work was completed on Xenia Court and Janet Drive. Some sections of Green will be done in a week or so. There was a significant outcry from James Street that they wanted to keep their sidewalks, so that will be addressed next Spring or Fall which will involve lifting and leveling some pieces and totally replacing others.

The Mayor passed around a picture of a speed monitor that he discussed with Lt. Dave Young of the Wharton Police Department. Wharton purchased two of them. The cost is \$4,000 each. They will monitor traffic and will do traffic studies, determining volume of traffic, average speed of traffic, all of which will help the Police to develop the best time frame to be patrolling certain roads to help alleviate speeding. The data is collected via cellular, laptop, SD card etc. The Council was in agreement that it is something the Town should look into current pricing and purchase.

Mine Hill Day is September 20<sup>th</sup>. There are 38 people for the 5K. Last year there were 100 runners and 80 joined the last week and a half. The Mayor will send out a Swiftreach message to remind residents. Garden State Fireworks will provide the fireworks show. There will be funnel cake. Ms. Kanzenbach asked to be informed about the next meeting in ample time.

Mayor Morris reported that the Town received a letter and report from Standard & Poor's Rating Services. The Town's rating improved two notches from AA- to AA+. The rating reflects Standard & Poor's assessment of the Township's: very strong economy, adequate management, very strong budgetary flexibility, very strong liquidity, very strong budgetary performance, very strong debt and contingent liabilities, and strong institutional framework. If the Town were to have to borrow, the Town could borrow at a cheaper rate.

Mayor Morris also discussed he is doing a study on the garbage utility. The garbage contract is up February 1, 2015. He is looking into whether it will be cheaper for the Town to do it or to contract it out.

Mayor Morris announced Delores Path is Open. There is a possibility that lights might be put along Baker and by the Canfield School.

Mr. Bucco returned at this time. 8:15pm

### REPORTS OF COUNCIL LIAISONS

## **Community Committee**

Mr. Coranato reported that soccer started this past weekend and is going. Mayor Morris mentioned basketball sign-ups will begin the end of September after the ordinance in regards to the fees is passed.

### **Board of Education**

Mr. Coranato reported that they discussed the maintenance that took place over the summer. They sealed the driveway, dealt with some roofing issues, re-did the gym floor; re-did sidewalks. They also updated the

second phase of the security by putting more cameras in the hallways. They put a device in that reads driver's licenses and are able to do a background check in order to make sure there are no restraining orders etc. Mr. Willis questioned what happens if the person does not have a license. Mr. Coranato replied that he would get back to him on that.

#### Fire & First Aid

The Mine Hill Fire Department attended the Boonton Parade and took First Place in the Color Guard (That is three years in a row.), Second Place for 2000 Pump Truck, and Third Place for the 1989 Pump Truck and '54 Mack.

The Mayor mentioned that 1989 Mack needs recertification which will give the Town another five years. The Town can get another recertification after that for a total of ten years. The Command Vehicle is ten years old and has rot in the quarters. It will go to a reputable shop and get an estimate and proceed from there.

#### **Police**

Mr. Pepperman mentioned he talked to the Police Department in regards to the Traffic Radar Speedometer, which will help narrow down the days and hours of speeding instances. They had a campaign for Click-It or Ticket-It. The final numbers were not available, but there were two DWI arrests in Mine Hill.

## **Open Space Committee**

Mr. Bloom reported the Open Space Committee will meet next week.

### **Planning Board**

Mr. Willis reported the Planning Board meets the next week.

Ms. Kanzenbach asked if the Town would be sending someone to the RVRSA and join as a member. Mr. Willis said he would go as the Town representative. Mayor Morris said Mr. Willis could attend the meetings. No final decision was made.

### **OPEN TO THE PUBLIC**

Mr. John Paschal of Thomastown Road voiced his concern in the Town insourcing the garbage pickup. He asked if Roxbury sold their garbage trucks and outsourced the garbage pick-up. Mr. Willis and Mayor Morris told him yes and that they subbed it out to Blue Diamond. Mr. Willis mentioned that there is a big difference between Mine Hill and Roxbury. Mayor Morris explained the breakdown and why it might be better for the Town to have garbage pickup completed by the Town as there would be a fifth DPW employee to help with plowing and many other areas. Mr. Willis added it would also help to have a fifth DPW employee when the MUA recycling contract runs out.

Mr. Paschal asked if a study was done in regards to how many trucks the Fire Department needs. Mayor Morris explained that all of the trucks the Fire Department has, will be kept as they have depreciated and are good for another ten years. Mayor Morris explained the truck maintenance is cheaper than it has been since Randall Garage completes most of the repairs.

Mr. Paschal voiced that he hopes the Town proceeds cautiously in regards to both areas.

Mr. Jeff Kitzmiller from Anderson Place mentioned he came home from vacation and found a speed bump was constructed in front of his home. He questioned how was it determined to place one there. Mayor Morris explained that it was decided by a certified traffic engineer. Mr. Kitzmiller asked if any of the residents were consulted. Mayor Morris mentioned three others in that area were consulted and they were not opposed to the speed bump. Mr. Kitzmiller said he was just trying to understand the process as he is the only one on the street with no off street parking, there is a fire hydrant in front of his house and if he does not keep his mailbox clear both 15 feet before and after it, he does not receive his mail. The Mayor apologized and acknowledged he understands Mr. Kitzmiller's situation and reassured him that the decision to put one there

was not done so without a lot of thought and discretion. The Mayor said he would talk with the Chief of Police about how the situation can be resolved.

Mr. Kitzmiller mentioned in order to control traffic a speed bump should be put on Clark to which the Mayor responded they are not allowed to due to the pitch. Mr. Pepperman said that would be a location to put the new traffic counter at in order to determine the time of the day it occurs. Mayor Morris agreed that the Traffic Radar Speedometer will help with that area.

Mr. Kitzmiller addressed the ordinance for clearing sidewalks of snow. He brought with him a piece of metal that came off a State plowing truck that came within 12 inches of hitting him when he was trying to clear the sidewalk during the past winter. He was wondering if something could be done in regards to the ordinance to provide some leeway when conditions are like what occurred this past winter. Discussion ensued that this past winter created very difficult situations in removing the snow and/or ice and that at times in the future, discretion will need to be made.

Mr. Paschal made a suggestion that plows should have some permanent stamp on the blades. The stamp would indicate whether it belongs to the State or a particular town in order to be able to hold that organization accountable for when instances like what happen to Mr. Kitzmiller occur.
