- Section 2. The Public Works Department is hereby authorized and directed to install any and all street signs and traffic markings reflecting the change of the street name from Second Street to Baker Street and the Township Clerk is hereby authorized to instruct the Township Engineer to revise the Township's Official Map to reflect the change in the street name.
- Section 3. The Township Clerk is hereby further authorized and directed to notify the Township Residents along said street of the effective date of the name change and to further advise all appropriate agencies, including but not limited to, the United States Post Office, the Police and Fire Departments, the First Aid Squad and the Morris County Department of Planning and Development of the change in said street name.
- Section 4. All ordinances of the Township of Mine Hill, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
- Section 5. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- Section 6. This Ordinance shall take effect upon final passage and publication as required by law.
