
PRESENTATIONS

Pancreatic Cancer Awareness Presentation

Resolution Declaring November 2014 as "Pancreatic Cancer Awareness Month"

Mr. Bloom discussed a friend who fought and succumbed to pancreatic cancer. A motion was made by Ms. Kanzenbach and seconded by Mr. Pepperman to adopt the following resolution. The roll was called and the resolution was adopted by the following vote:

WHEREAS in 2014, an estimated 46,420 people will be diagnosed with pancreatic cancer in the United States and 39,590 will die from the disease;

WHEREAS pancreatic cancer is one of the deadliest cancers, is currently the fourth leading cause of cancer death in the United States and is projected to become the second by 2020;

WHEREAS pancreatic cancer is the only major cancer with a five-year relative survival rate in the single digits at just six percent;

WHEREAS when symptoms of pancreatic cancer present themselves, it is generally late stage, and 73 percent of pancreatic cancer patients die within the first year of their diagnosis while 94 percent of pancreatic cancer patients die within the first five years;

WHEREAS approximately 1220 deaths will occur in New Jersey in 2014;

WHEREAS the Recalcitrant Cancer Research Act was signed into law in 2013, which calls on the National Cancer Institute to develop a scientific framework, or strategic plans, for pancreatic cancer and other deadly cancers, which will help provide the strategic direction and guidance needed to make true progress against these diseases; and

WHEREAS the Pancreatic Cancer Action Network is the national organization serving the pancreatic cancer community in Mine Hill and nationwide through a comprehensive approach that includes public policy, research funding, patient services, and public awareness and education related to developing effective treatments and a cure for pancreatic cancer;

WHEREAS the Pancreatic Cancer Action Network and its affiliates in Mine Hill support those patients currently battling pancreatic cancer, as well as to those who have lost their lives to the disease, and are committed to nothing less than a cure;

WHEREAS the good health and well-being of the residents of Mine Hill are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes, and effective treatments.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Mine Hill, in the County of Morris and State of New Jersey, that the month of November 2014 be designated as "Pancreatic Cancer Awareness Month" in Mine Hill.

Ordinance 23-14A An Ordinance Renaming Second Street as Baker Street

WHEREAS, the Township Council wishes to rename Second Street between Canfield Avenue and Baker Street to establish Baker Street as a continuous street from Canfield Avenue to Route 46 in the Township; and

WHEREAS, the Township Council believes that changing the name of Second Street to Baker Street is in the best interest of the Township.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Mine Hill, in the County of Morris and State of New Jersey, as follows:

- Section 1. The street name of "Second Street" between Canfield Avenue and Baker Street, in the Township of Mine Hill, County of Morris shall be renamed "Baker Street".
- Section 2. The Public Works Department is hereby authorized and directed to install any and all street signs and traffic markings reflecting the change of the street name from Second Street to Baker Street and the Township Clerk is hereby authorized to instruct the Township Engineer to revise the Township's Official Map to reflect the change in the street name.
- Section 3. The Township Clerk is hereby further authorized and directed to notify the Township Residents along said street of the effective date of the name change and to further advise all appropriate agencies, including but not limited to, the United States Post Office, the Police and Fire Departments, the First Aid Squad and the Morris County Department of Planning and Development of the change in said street name.
- Section 4. All ordinances of the Township of Mine Hill, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
- Section 5. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- Section 6. This Ordinance shall take effect upon final passage and publication as required by law.
