WHEREAS, the Local Fiscal Affairs Law N.J.S.A. 40A:5-2, N.J.S.A. 40A:5-14 and N.J.S.A. 40A:5-15.1 requires that each local unit shall adopt a cash management plan,

NOW, THEREFORE BE IT RESOLVED that the following shall constitute the Cash Management Plan for the Township of Mine Hill and the Treasurer shall deposit and manage its funds pursuant to this plan.

Definitions

- 1. Treasurer shall mean the Treasurer of the Township of Mine Hill.
- 2. Fiscal Year shall mean the twelve month period ending December thirty-one.
- 3. Cash Management Plan shall mean that plan as approved by resolution.

Designation of Depositories

At least once each fiscal year the governing body shall by resolution designate the depositories for the Township of Mine Hill in accordance with N.J.S.A. 40A:5-14. The depositories shall be GUDPA approved depository banks and the New Jersey Cash Management Fund.

Audit Requirement

The Cash Management Plan shall be designed to assure to the extent practicable the investment of local funds in interest bearing accounts and other permitted investments as allowed by Statute. The Cash Management Plan is subject to the annual audit conducted pursuant to N.J.S.A. 40A:5-4.

Investment Instruments

The Treasurer shall invest at his/her discretion in any investment instrument as approved by the State of New Jersey in accordance with N.J.S.A. 40A:5-15.1.

Records and Reports

The Treasurer shall report all investments in accordance with N.J.S.A. 40A:5-15.2.

At a minimum, the Treasurer shall:

- 1. Keep a record of all investments.
- 2. Keep a cash position record which reveals, on a daily basis, the status of the cash in its bank accounts
- 3. Confirm investments with the governing body at the next regularly scheduled meeting.
- 4. Ensure all moneys are deposited in accordance with N.J.S.A. 40A:5-15.

Cash Flow

The Treasurer is authorized and directed to invest surplus funds of the Township of Mine Hill as the availability of the funds permit. In addition, it shall be the responsibility of the Treasurer to minimize the possibility of idle cash by depositing the monies in interest bearing accounts wherever practical and in the best interest of the Township of Mine Hill.

The Treasurer is charged with the custody of monies of the Township of Mine Hill and shall deposit them as designated by the Cash Management Plan and shall thereafter be relieved of any liability for loss of such monies due to the insolvency or closing of any depository designated by, or the decrease in value of any investment authorized by, the Cash Management Plan pursuant to N.J.S.A. 40A:5-14F.

Resolution 009-12 - Fixing Rate of Interest for Delinquent Payment of Taxes or Assessments

WHEREAS, N.J.S.A 54:4-67 permits the governing body of each municipality to fix the rate of interest to be charged for non-payment of Taxes, Assessments, Water and Sewer charges and other amounts that may be assessed by the Township (hereinafter referred to as "Municipal Charges") subject to any abatement or discount for the late payment of Municipal Charges as provided by law; and

WHEREAS, N.J.S.A 54:4-67 has been amended to permit fixing of said rate of 8% per annum on the first \$1,500.00 of the delinquency and 18% per annum on any amount in excess of \$1,500.00 and 6% year end penalty on any delinquent Municipal Charges due the 31st day of December in excess of \$10,000.00.

NOW, THEREFORE BE IT RESOLVED, by the Township Council of the Township of Mine Hill this 1st day of January, 2012 as follows:

- 1. The Tax Collector is hereby authorized and directed to charge 8% per annum on the first \$1,500.00 of Municipal Charges becoming delinquent after the due date and 18% per annum on any amount of Municipal Charges in excess of \$1,500.00 becoming delinquent after the due date and if a delinquency is in excess of \$10,000.00 and remains in arrears beyond December 31st of each year an additional penalty of 6% shall be charged against the delinquency.
- 2. The ten (10) day grace period for Municipal Charges will remain in effect for 2012.
- 3. Any payments not made in accordance with paragraph 2 of this resolution shall be charged interest from the date set forth on paragraph 1 of this resolution.
- 4. This resolution shall be published in its entirety once in the official newspaper of the Township.

3.		tes of the closed session and any other information required to be shown in the minutes by law, be promptly available to the public when the matters discussed are resolved, to the extent that		

- shall be promptly available to the public when the matters discussed are resolved, to the extent the making such matters public shall not be inconsistent with section N.J.S.A. 10:4-12.
- 4. The Township Council may come back into open session and take further action.
- 5. This Resolution shall take effect immediately.

Upon conclusion of closed session discussion, a motion was made, seconded and approved by a vote of all ayes to return to open session.

OPEN TO THE PUBLIC AND COUNCIL COMMENTS

Mr. Coranato noted that he believes that the auditor proposal from Nisivoccia, LLP was lower than in past years because CFO Janice Congleton is able to perform various tasks that were previously handled by the firm. Ms. Kathi Mantell of Nisivoccia, LLP was invited to speak regarding her proposal and answer questions from the Council.
