3. For services larger than $1 \frac{1}{2}$ inches, the water department shall determine the service connection fee to be charged based upon the costs to the township in making such connection.

SECTION 2. Chapter 13.04, Section 13.04.050, entitled "Services-Water Department Side", is hereby amended by the following amendment to Paragraph C which shall read, in its entirety, as follows:

C. No person may operate the curb shut off at any time except agents of the water department or with the written consent of said agent.

SECTION 3. Chapter 13.04, Section 13.04.060, entitled "Services-Owner's Side", shall be amended by the following amendment to Paragraph E which shall read, in its entirety, as follows:

E. The owner shall be responsible for the maintenance of service line from the property line to the meter to the interior of the building, and shall keep the same in good repair and protect it from damage due to frost or other cause. All leaks in the service lines shall be reported promptly to the water department and repaired by the owner. The owner shall be liable for water escaping from such leaks at a charge of \$250.00 per day from the date said leak is discovered. If the leak persists for more than 10 (ten) consecutive days, the charge will be increased to \$1,000.00 per day. If leak is repaired in three (3) days or less, any charge shall be waived.

SECTION 4. Chapter 13.04, Section 13.04.070, entitled "Meters and Metering", shall be amended by the following amendments to subsections C through F and Subsection O which shall be amended to read in their entirety as follows and by the repeal of Subsections G, H, and L:

- C. Meters 1 $\frac{1}{2}$ inches and smaller shall be paid for by the owner and installed by the water department at the same cost as to the Township.
- D. Meters two inches and larger shall be of a make and model designated by the water department, purchases by and installed by the owner.
- E. Meter settings shall be prepared by the owner as follows: five-eighths inch through one inch meters shall require a meter yoke installed by the owner and purchased from the water department at same cost as to the Township.
- F. All meters shall be provided with remote radio devices. Homeowners must allow water department personnel access to the meter, with reasonable notice, during the normal business day. Any homeowner denying access to said meter will be charged \$250.00 per day, from date of notification. This charge will be waived if access is granted within three (3) business days.
- O. When an appointment is not kept by the homeowner and a repeat visit is necessitated there will be a fifty dollar charge per additional visit. If there is a meter reading discrepancy caused by this office there will be no charge. However, if the meter is correct there will be a fifty dollar charge for revisiting to read the meter.

SECTION 5. Chapter 13.04, Section 13.04.080, entitled "Meter Tests", shall be amended by the following amendment to Subparagraphs C and D which shall read in their entirety as follows:

C. Meter test fees are as follows: Meter Size Charge 5/8 inch \$50.00 3/4 inch \$50.00 1 inch \$75.00

Meters larger than one inch at cost but not less than \$100.00

D. If a meter is found to be registering more than two percent fast at any rate of flow, the customer shall be entitled to an adjustment of his or her bill for the current quarter.

SECTION 6. Chapter 13.04, Section13.04.090, entitled "Meter Damage or Loss", shall be amended to be entitled "Meter Damage, Loss or Tampering and Curb Box or Transmission Equipment Tampering" and shall be amended by the following amendment to Subsection C and the addition of new Subsections G, H, and I which shall read in their entirety as follows:

C. Meter repair fees for frozen meters or damaged meters shall be at the same cost as to the Township to replace or repair the meter.

G. Meter tampering is a violation of this Chapter and shall be upon conviction result in a penalty of \$1,000 for the first offense, \$2,500 and up to 5 days in jail for the second offense, and \$5,000 and up to 30 days in jail for the third offense.

H. Tampering with the curb box or transmission equipment of the water meter reading system is a violation and shall be upon conviction liable to a penalty of \$1,000 for the first offense, \$2,500 and up to 5 days in jail for the second offense, and \$5,000 and up to 30 days in jail for the third offense.

I. All plumbers must have prior written approval from the water department to restore water flow to the home. The failure to have written approval is a violation of this Chapter and shall be upon conviction liable to a penalty of \$1,000 for the first offense, \$2,500 and up to 5 days in jail for the second offense, and \$5,000 and up to 30 days in jail for the third offense.

SECTION 7. Chapter 13.04, Chapter 13.04.120, entitled "Miscellaneous Fees" is hereby amended by the following amendment to Paragraphs A and B which shall read in their entirety as follows:

A. Service Line Inspection – Curb Stop to House. The fee for inspection of trenches and pipe on private property shall be fifty dollars per visit.

B. Voluntary Discontinuance of Service.

- 1. The turn off and on charge for weekdays shall be one hundred (\$100.00) dollars (2 visits).
 - 2. The turn on and off charge after three-thirty p.m. weekdays and all day on holidays and weekends shall be two hundred (\$200.00) dollars (2 visits).

The Community Committee shall consist of up to eleven (11) voting members to be appointed by the Mayor with the advice and consent of the Council. Two (2) of the eleven (11) members shall be the Mayor and one Council Member. Members shall be appointed annually for a two year term. Members of the Committee shall serve without compensation. The Committee shall designate one (1) of its members to serve as chairperson and presiding officer of the Committee. The Committee is authorized to adopt bylaws governing its procedural operations.

2/113.020 Powers and duties.

The Community Committee shall advise the Administration and Township Council concerning the planning, implementation, and promotion of Social Service Programs and Community Building Programs. It is understood that the Community Committee will act merely in an advisory capacity and shall not have the power to bind the Township in any manner.

2.113.030 Director of Community Programs.

The Mayor, with the advice and consent of the Council, may appoint a Director of Community Programs to administer social service and community building programs.

SECTION 2. This Ordinance may be renumbered for codification purposes.

SECTION 3. All Ordinances of the Township of Mine Hill which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 5. This ordinance shall take effect 20 days after final passage and approval by the Mayor and upon publication in the manner provided by law.

ADMINISTRATIVE AGENDA

Administrator

Mr. Thompson reported that, since the beginning of the year, Mary Williams has been assisting in construction sending out letters and cracking down on landlord registration. The Township has collected over \$5,900 so far through this effort; however, the project is less about the money and more about preventing stacking. Potential violators have been identified through tax records, etc., and Mrs. Williams has done a great job with the follow up.

Mr. Thompson reported that he is still communicating with the Dover Court regarding the addition of Victory Gardens. Mr. Bucco recommended a formal letter to the Town of Dover indicating that Mine Hill would not be entertaining the required resolution until the information request was received.

It was noted that five resumes were received in response to the advertisement for Director of Community Programs. Interviews will be conducted and Mr. Thompson will be reporting back to Mayor and Council.

Mayor

Mr. Morris asked that the New Business item regarding water meter installation be moved up to this point in the meeting.

Mr. Morris explained that the Township is examining the price difference between going out to bid for a contractor to install the new water meters versus hiring temporary employees to perform the installation in house. The conclusion is that temporary employees could install the meters for approximately \$40/meter and a contractor would likely cost approximately \$100/meter.

Tax Collector Judi O'Brien explained that the intention is to begin work with the oldest parts of Town, namely the Flats and Basset Park. A letter will be sent to all residents in Town in general preparation, and then a more specific mailing will be going out when work approaches the various parts of Town. Appointments will be scheduled as close together as possible. Following the oldest parts of Town, work will proceed to "bulk" areas such as the condo complexes, and then proceed to the rest of Town. It was noted that the ordinance that was adopted establishes penalties for a resident's failure to provide access to their meter.

Mr. Morris also reported that the Community Block Grant has been awarded to the Township to provide \$80,000 in funding for mine remediation under the walking path behind the school. This project will be moving forward soon.

Mr. Morris also met with representatives from the State division of fire safety to discuss budgetary matters such as the length of life of a firefighter's protective equipment. He learned that turnout gear is said to last ten years, but that the estimate is based on almost daily use in a high activity city environment. Gear can be sent back to the manufacturer to be tested and certified to still be in safe and usable condition.

Mr. Bloom reported that JORBA (Jersey Off Road Bicycle Association) has been working on walking/biking trail restoration. JORBA plans to come to a meeting in May to discuss their work and future plans.

Chris Cole, Canfield Avenue

Mr. Cole asked when the sidewalk up to the School would be installed. Mr. Morris responded that the hope was to complete the work while school is out for the summer.

Tim Beyrent, Lakeshore Drive

Mr. Beyrent inquired about flood control at the brook. He indicated that children have been known to make small bridges over the brook by putting debris in the water and subsequently blocking the flow. He and a neighbor built a small bridge to prevent this, but that bridge was removed after a neighbor complained. He asked if anything could be done to create a safe way to cross the brook. Mr. Morris responded that, according to NJDEP, anything placed within 25 feet of the brook, including means of crossing, is a wetlands violation.

Mr. Beyrent also inquired about the beach concession stand. Mr. Morris indicated that the intention was to go out to bid for outsourcing that function, but it is too late in the year to pursue that process at this time; the concession stand will likely be run for one more year with municipal employees. Mr. Beyrent responded that he is concerned for the future of the family atmosphere if the concession stand is privatized and outside food is prohibited.

John Paschal, Thomastown Road

Mr. Paschal inquired about the status of the farm overlay ordinance. Mr. Morris responded that the draft was received today and would be followed up on in the near future.
