8.44.010 Purpose.

The purpose of this chapter is to set forth a code regulating the location, construction, use, maintenance and method of emptying or cleaning individual sewage disposal systems. The issuance of licenses and permits to locate, construct, empty or clean the systems and fixing penalties for the violation thereof is adopted pursuant to Chapter 188, P.L. 1950 (N.J.A.C. 7:9A). A copy of the code is annexed hereto and made a part of this chapter without inclusion of the text thereof in this chapter.

8.44.020 Short title.

The code established and adopted by this chapter is described and commonly known as the "Standards for Individual Subsurface Sewage Disposal Systems."

8.44.030 Public record.

Three copies of the Standards for Individual Subsurface Sewage Disposal Systems have been placed on file in the office of the secretary, clerk or other similar officer of the department of department of health upon the introduction of this chapter and will remain on file in the office for the use and examination of the public.

8.44.040 Permit required.

No person shall locate, construct or alter any individual sewage disposal system until a permit for the location, construction or alteration of the sewage disposal system shall have been issued by the department of department of health.

8.44.050 Certificate of compliance required.

New individual disposal systems shall not be placed in operation nor shall new dwellings or buildings or additions thereto be sold or occupied, which must rely on such a system for sewage disposal, until the department of department of health shall have issued a certificate indicating that the disposal system has been located and constructed in compliance with the terms of the permit issued and the requirements of the code.

8.44.060 Denial of license, permit or certification—Hearing.

In case any license, permit or certification required by this chapter is denied by the department of department of health, a hearing shall be held thereon before the department within fifteen (15) days after the request therefor is made by the applicant and upon such hearing the department of department of health shall affirm, alter or rescind its previous determination and take action accordingly within fifteen (15) days after the date of such hearing.

8.44.070 Order to stop work.

The department of department of health may order all further work in and about any individual sewage disposal system, which is being erected or installed in violation of the code, to be stopped forthwith, except such work as shall be necessary to remedy such violation, and thereafter, the work continued without any violation of any of the provisions of the code, and after issuance of any such order and the service of a copy thereof upon any person connected with or working in and about the erection or installation of any such disposal system, or any part thereof, no further work shall be done thereon except as aforesaid.

8.44.080 Fees and charges.

The following fees and charges are established in order to defray the cost to the township for the filing of plans, processing, and inspection of sewage disposal systems:

C. The permits under this section shall expire one year from the date of issue. The renewal fee for the reissuance of the aforesaid permits shall be fifty dollars (\$50.00).

D. Re-inspection fee \$50.00

8.44.090 Violations Penalties.

Any person violating any of the provisions of or any order promulgated under this chapter or the Standards for Individual Subsurface Sewage Disposal Systems made a part hereof shall, upon conviction thereof, be subject to the general penalty as established in Chapter 1.08 of this code.

SECTION 2. All ordinances of the Township of Mine Hill which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 4. This ordinance shall take effect 20 days after final passage and approval by the Mayor and upon publication in the manner provided by law.

Robert Keller, Frank Street

Mr. Keller is confused as to the Chief saying the proposal is substantially different and the Council is saying it is different but not substantial. Mr. Willis responded that Wharton is free to completely decline this proposal and move forward with the previous proposal. Mr. Morris hopes that this proposal will lead to a sit-down discussion that results in a contract.

Cheryl Doltz, Williams Street

Ms. Doltz expressed concern with a house on Williams Street that had a fire several years ago and is currently uninhabitable. The house's padlocked door is pushed open and is attracting wildlife. Across the street from this house is a home that is being used as a business. Both of these houses are lowering property values on the street. Mr. Thompson responded that he has issued a summons to the home running a business and will be in court with them next week. He added that the fines will likely be substantial and may actually result in prison time for them. Mr. Oostdyk responded that the house that burned is being investigated by his firm to learn what is on the title search. Once the title search comes back, action can be taken.

Pat Burbridge, Thomastown Road

Mr. Burbridge thanked the Police Department, Fire Department and First Aid Squad for their work during the hurricane.

Mr. Burbridge asked why Congressman Lance is not paying rent to have his office here. Mr. Morris responded that it is costing us nothing to have him here so there is no reason for him to pay rent.

ADMINISTRATIVE AGENDA

Mr. Morris reported that we would be receiving two grants for sidewalks. The engineer is recommending preparing the RFP for the work and waiting until next fall/winter to go out to bid to get better prices. The project would then be executed in 2014. He added that the project at Thomastown and West Randolph will be worked on when the frost thaws in the spring.

Mr. Coranato asked if the Township could pay for the Rutgers Safety course and make donations to the Junior Knights. Mr. Morris responded that the safety course could be paid for only for Township residents. He also responded that the Township is not permitted to make donations to outside organizations such as the Junior Knights.

Mr. Morris announced that the budget workshop meeting would be held all day during the day next Wednesday.

Mr. Thompson reported that the building inspector/fire sub-code official Bill Donnerstag would be replacing him as zoning officer when he retires. Various current zoning violations were discussed.
