## PUBLIC HEARING ON ORDINANCES PREVIOUSLY INTRODUCED

# Ordinance 07-13 Establishing Fees for Use of Facilities

A motion was made by Ms. Kanzenbach and seconded by Mr. Pepperman to open the public hearing on this ordinance. Brief discussion regarding the origins of the ordinance followed.

Seeing no further discussion from the Council or the public, a motion was made by Mr. Pepperman and seconded by Ms. Kanzenbach to close the public hearing.

BE IT ORDAINED, by the Township Council of the Township of Mine Hill, in the County of Morris, and State of New Jersey, as follows:

SECTION 1. Title 12 of the Revised General Ordinances of the Township of Mine Hill entitled "Streets, Sidewalks, and Public Places" shall be amended by the inclusion of new Chapter 12.46 entitled "Civic Center" which shall read in its entirety as follows:

12.46 Civic Center

## 12.46.010 Use of Civic Center

Organizations desiring to utilize the Civic Center for meetings, recreation, or other purposes may be granted permission to utilize the Civic Center under conditions set forth in the Township of Mine Hill's "Policy for Use of Township Facilities."

12.46.20 Fee for use of Civic Center

Organizations using the Civic Center shall pay a fee as follows:

\$100.00 day use rate \$50.00 evening rate

A not for profit organization which does not charge fees for the activity taking place at the Civic Center shall be exempt from the fee. A not for profit organization which charges fees for the activity taking place at the Civic Center shall pay a reduced fee of \$40.00 for day use and \$25.00 for evening use.

SECTION 2. This Ordinance may be renumbered for codification purposes.

SECTION 3. All Ordinances of the Township of Mine Hill which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 5. This ordinance shall take effect 20 days after final passage and approval by the Mayor and upon publication in the manner provided by law.

#### ADMINISTRATIVE AGENDA

Mr. Thompson introduced Jennifer Blouse as the new Construction Department Secretary.

Mr. Thompson reported that two recent zoning matters that went to court were both concluded in the Township's favor. He added that the Township will be receiving more than \$14,000 in reimbursements from FEMA for the storms.

Mr. Thompson noted that the Town of Dover has given the Township notice that their water system will no longer be supplying water to the last few houses in town that are currently hooked into their system. The Township will have to run a water line to these homes, approximately half a mile from the nearest point in our system.

Mr. Thompson advised the Council that the Planning Board has almost completed review of the Land Use Ordinance and it will be coming before the Council at the next meeting. He noted that the ordinance is long, but it isn't changing laws; the changes are mostly grammatical. He recommended passing the ordinance without taking the time for a lengthy review as it will be reviewed by the Codification company in the recodification process and we will have several opportunities to ensure that it is accurate.

Discussion was held regarding the loan of generators to residents during storms as was done during the hurricane. It was noted that a release will be written for future use.

Mr. Morris reported that Mr. Thompson has officially submitted for retirement effective July 1<sup>st</sup>. He has received more than thirty resumes and intends to interview approximately half a dozen candidates for the administrator position. He added that one of the interviewees may be school superintendent Dennis Mack who is retiring from the school system this summer. He is also investigating the possibility that Mr. Mack may be able to act in an advisory capacity to the new superintendent.

Mr. Morris advised the Council that he presented the budget to the Seniors at their meeting last week. Some were displeased with the increase, but most were pleased to at least have the process explained to them.

Mr. Morris noted that ReCommunity on Iron Mountain Road will be building a sound dampening wall in an attempt to block both noise and litter from reaching Autumn Drive and Crimson Lane. A letter will be sent to the residents of that neighborhood to advise them of these proceedings.

Mr. Morris reported that the beach will be opening up on the Friday of Memorial Day weekend. The schedule has been amended in an effort to be more cost effective based on last year's attendance.

Mr. Morris noted a complaint from Wharton Avenue regarding drainage off of Route 46. NJ DOT will be sending a crew to investigate the problem.

Mr. Morris reported that the roof of Town Hall needs to be replaced. The project is being researched by Maser Consulting.

Discussion was held regarding the mulch site operation. Mr. Morris noted that the rules will be enforced more rigidly than in the past. Further discussion followed regarding other recycling operations.

It was noted that water reports that will compare last year to this year will be available at the next meeting.

Discussion was held regarding recreation field space with the potential loss of the field where the hole is located. The main field may have to be shut down to update the quality of the large field to improve the overall quality in the long term.

Mr. Morris noted that First Aid response time has become a concern at certain times of the day. He is recommending that we set up for our backup to be St. Clare's. The downside is that St. Clare's will charge residents for the ambulance ride.

Mr. Pepperman reported that the department is in the process of purchasing new vehicles. It was note that the FOB is purchasing a scoreboard for school/recreation programs.

Mr. Frank asked if anyone had picked up the grist stone found in the mulch site. Mr. Morris will call Bill Orlandi to investigate the possible historical significance of the item.

WHEREAS, the Morris County Historic Preservation Trust Fund makes funds available to municipalities for the acquisition, stabilization, rehabilitation, restoration or preservation of historic resources; and

WHEREAS, the Township of Mine Hill holds title to the Bridgit Smith House, a c.1855 miners home which is recorded in the National and New Jersey Register of Historic Places; and

WHEREAS, the Ferro Monte Historical Society, which is charged with preserving and maintaining the Bridgit Smith House, has requested that the Township apply for a grant from the Morris County Historic Preservation Trust to fund construction documents, drawing and specifications for the restoration of the interior of the Bridget Smith House; and

WHEREAS, the Mayor and Council have considered this recommendation.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Mine Hill, in the County of Morris and State of New Jersey formally approves the grant application for the above stated project.

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized to sign the grant agreement on behalf of the Township of Mine Hill to the extent that the agreement is not inconsistent with the Township's 2013 budget, and that their signatures constitute acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.

#### **Update on Fireman's Field**

Mr. Morris added that the studies on the field have been completed and he is awaiting reports. He plans to have the engineers come to present the reports to the Council.

#### **Discussion of Personnel Manual**

Mr. Thompson noted that the original personnel manual will be reviewed by the attorneys, the insurance company, and Council and will be readopted as revised.

Mr. Morris noted that he is meeting with Maser Consulting to walk Randolph Avenue next Wednesday to address some concerns in the current sidewalk plans.

Mr. Paschal discussed possible remedies for the sidewalk and tree problem on Autumn Drive. He suggested that the neighborhood be poled and if they choose to not have the trees removed that they become responsible for the sidewalks.

Gary Colucci, Williams Street

Mr. Colucci thanked the Council for the resolution supporting the historic grant.

Mr. Morris noted that Mine Hill Day in September would include a celebration of the Township's 90<sup>th</sup> anniversary.

Gary Frank, Thomastown Road

Mr. Frank suggested obtaining sponsors for the field to help with repairs and maintenance.

There being no further business, a motion was made by Mr. Bloom and seconded by Ms. Kanzenbach to adjourn the meeting at 9:13 PM. The motion was approved by a voice vote.
