#### **ADMINISTRATIVE AGENDA**

Mr. Thompson reported that water losses are down from 52% to 21%. The monitoring system is working very well; a detailed water report was recently able to prove that a resident experienced two usage spikes, most likely from running toilets.

Mr. Morris reported that the first "meter cheater" was caught recently. The meter was identified when it reported "no read" and DPW went to check on it. The battery had been disconnected, made obvious by a pin that needs to be ripped out to access the battery. The meter also continued to record the water usage and the reading spiked upon reconnection of the battery. Tampering with meters is covered by the municipal ordinance and the individual will be fined.

Mr. Morris added that the goal is to be below 10% water loss. Toward that end, the Township will be purchasing four fixtures that can be moved around the water system throughout town to detect leaks in the mains. The water tower will also have to be discussed.

Mr. Morris noted that he has appointed Bill Donnerstag as Zoning Officer effective immediately. This will allow Mr. Donnerstag to begin enforcement so that Mr. Thompson will not have any pending court cases upon his retirement.

Mr. Bloom reported that the principal recently finished his doctorate. Police have been working with school officials to coordinate enforcement of the traffic pattern and parking in the school parking lot.

### Fire & First Aid

Ms. Kanzenbach relayed information provided by the First Aid Squad pertaining to ambulance calls over the last several months. Mr. Morris reported that he met with members of the Squad pertaining to daytime coverage. Consensus of opinion is to have a professional service serve as third call during the daytime hours when coverage is limited. Discussion followed regarding the possibility of having a professional third call all day and night. It was concluded that Mr. Morris would pursue daytime coverage and see how it works out before pursuing nighttime coverage as well.

#### INTRODUCTION OF ORDINANCES

#### Ordinance 08-13 Prohibiting Motorcycles and All-Terrain Vehicles on Public Property

A motion was made by Ms. Kanzenbach and seconded by Mr. Coranato to introduce the ordinance. The roll was called and the ordinance was introduced by the following vote:

BE IT ORDAINED by the Township Council of the Township of Mine Hill, County of Morris and State of New Jersey, as follows:

- SECTION 1. Chapter 10.36 of the Revised General Ordinance of the Township of Mine Hill, entitled "Motorized Vehicles, Off Road," is hereby amended by the following amendment to Subsection 10.36.030 ("Prohibited Acts") which shall read in its entirety as follows:
- A. It shall be unlawful for any person to operate or permit to or suffer to be operated a motorized sports bike, as defined herein, on any public grounds or property, including playgrounds and recreational areas. It shall be unlawful for any person to operate or permit to suffer to be operated a motorcycle on public grounds or property (including playgrounds and recreational areas) except on public streets or highways as defined in NJSA 39:1-1 and public parking areas.
- B. To operate a motorized sportbike or motorcycle, as a licensed or unlicensed operator, on private property other than with the written consent of all of the owners of said property. When such written consent has been obtained, the operator shall keep same on his or her person for display to the authorities. The failure to present such written consent upon request or demand shall constitute a violation hereunder.
- C. To operate a motorized sportbike or motorcycle other than in accordance with the general regulations set forth in Section 10.26.040 of this chapter.
- D. To operate a motorized sportbike or motorcycle in such a way as to harass or disturb farm animals, domestic livestock or wildlife or further to destroy or damage crops, cropland, soils or vegetation.
- E. To operate a motorized sportbike or motorcycle without the same being in "proper operating condition," which is defined as the presence of all original operating equipment specified therefore by the original manufacturer or with the same in operating condition at least equal to the manufacturer's requirements for the proper operation thereof or the equivalent thereof.
- F. To operate a motorized sportbike or motorcycle in a careless, reckless or negligent manner so as to endanger the safety or property of any person or public or private property, or in violation of the provisions of the Township's noise ordinance, Chapter 8.32. (Ord. 20-06 § 1 (part), 2006).
- SECTION 2. This Ordinance may be renumbered for codification purposes.
- SECTION 3. All Ordinances of the Township of Mine Hill which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
- SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
- SECTION 5. This ordinance shall take effect 20 days after final passage and approval by the Mayor and upon publication in the manner provided by law.

succeeding annual budgets by the inclusion of an appropriation of at least one-fifth of the amount authorized pursuant to this act.

NOW, THEREFORE BE IT RESOLVED, (by not less than two-thirds of all governing body members affirmatively concurring) that in accordance with the provisions of NJS 40A:4-55:

- 4. That two (2) certified copies of this resolution will be filed with the Director of the Division of Local Government Services; however, no approval is required from the Division.

He put into their record that, while not in favor of rate increases, he is in favor of empowering utilities in matters of communication with each other. He charged the Board of Public Utilities with installing a mechanism for communication between the various utilities. He also noted support for legislation to permit utilities to practice more drastic tree cutting measures to protect lines in an emergency.
