The Foundation, in partnership with Buy-A-Ride, is also donating a pavilion to be installed at the school.

Mr. Morris added that he considers this to be "The Year of In-Sourcing" wherein the Township is investigating the purchase of the right equipment to be able to improve efficiency and subsequently the budget for various projects.

Mr. Coranato reported that the recent food drive and the Memorial Day picnic were both extremely successful. Mine Hill Day is currently being discussed and planned.

One of the members of the Community Committee presented a Zoe Fluid Monitor. The machine helps determine the level of fluid in a person's body. She is recommending obtaining machines for public safety.

Discussion of Farm Animals in the Residential Zone

Mr. Bucco explained that the Ordinance currently does address this issue, but it can be amended to increase required lot sizes, etc. to make it more effective. He advised the Council to decide what they would like the standard to be, within reason, and it can be amended as part of the adoption of the new land use ordinance. Discussion of the recodification followed.

Discussion of Construction Department Inspection Fees

Mr. Thompson discussed implementing a fee for reinspection for when a property owner misses an inspection appointment. He is suggesting that the first reinspection not have an additional fee because extenuating circumstances happen, but that there be a charge for reoccurring "no-show" property owners.
