SECTION 1. Chapter 25, "Land Use Regulations," of the Revised General Ordinances of the Township of Mine Hill shall be amended to read, in its entirety, as set forth in the attached.

SECTION 2. This Ordinance may be renumbered for codification purposes.

SECTION 3. All Ordinances of the Township of Mine Hill which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 5. This ordinance shall take effect 20 days after final passage and approval by the Mayor and upon publication in the manner provided by law.

Mr. Morris introduced Mike Obremski from JCP&L to talk about the recent power outage. Mr. Obremski explained the reasons for the outage and how it was responded to. Various trees and polls within the Township were discussed. Swiftreach was also discussed, noting that the feedback was very positive.

Mr. Morris reported that he has conducted a few telephone interviews with candidates for the Administrator/CMFO position. He has learned that the Township is very unlikely to find a candidate with any quality experience for less than \$90,000. He added that the office is running very smoothly and he doesn't believe the Township needs to pay that much for a person who may not really be necessary.

Mr. Morris intends to meet with Morris County Administration to discuss the possibility of utilizing one of their Deputy Administrators for the specific functions for which the Township needs an Administrator such as grants.

Mr. Morris reported that NJ DOT visited today to learn the local opinion of the intersection of Route 46 and Canfield Avenue, and to discuss the Baker Street crosswalk which will hopefully be installed by Labor Day.

Mr. Morris reported that sidewalk repairs by DPW are underway. Recently acquired DPW equipment was discussed.

Mr. Morris and Ms. Macchia discussed the clerical staff person that has been hired for the summer. All of the Planning Board and Board of Adjustment files have been organized by block and lot, boxed and filed in the recently created file room. Old open permits in the Construction office have been closed out, and various other clerical projects have been completed as well.

Mr. Morris noted that Iron Mountain Road is beginning to sign leases for recreational uses of the industrial park.

Mr. Morris discussed proposed changes to tree maintenance ordinances and a Township Employee Education Policy. He also noted an upcoming meeting with Blue Diamond to discuss service quality, fire truck repairs, speed bumps.
