John Paschal of Thomastown Road asked for more details about the water leak. Mr. Morris responded with additional details.

Sandy Seibert of Maple Avenue remarked that she thought the townhouses at the end of Thomastown coming on the tax rolls would lower taxes throughout the Township. Mr. Morris explained that, rather than reducing taxes, additional funds were put into the capital account to allow for the overdue paving of Thomastown Road and First Street without having to borrow the money to do so. Next year, the \$90,000 annual payment on the fire truck will come off the books. Those funds will also be put into capital projects rather than tax decreases because there are other roads in need of paving and Township buildings in need of repair, as well as debts that the Governing Body would like to pay off sooner rather than later. The goal is to eventually pay off all debts, keep taxes flat, and keep enough funds in capital to avoid future borrowing. Improving the Township's reserves also improves the bond rating, so if future borrowing became necessary the best possible rates could be applied for.

Section 3. Said improvements are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefitted.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
