ADMINISTRATIVE AGENDA

Mayor Sam Morris discussed that the bases for the lights and conduits are in on Delores Path from the corner of Baker Street out to Delores Place. The County inspectors came out and are very happy with the progress. Canfield School is very interested in running theirs down and around in front of the school. The circuitry is wired to feed all the way from in front of the school and from the corner all the way down to the Fire House. Once the Town has it all set up with the correct brightness etc., the School will be set up.

The Renaming Baker Street and Second due to the confusion it causes for the school and also since there is another Second Street down below. There is one house, and the Town will need to talk to them and also talk to the Post Master and Chief of Police.

A letter was sent out to James Street about pulling out the sidewalks and the Mayor only received one call. DPW started digging out the sidewalks on Xenia and should be done by next week.

NJ Natural Gas has completed the gas runs on George Street, Dickerson Mine Road and Green Road. There is a huge turnout of interest on Hurd Street. There is also a number of residents interested down in the Flats. There is one issue on Dickerson Mine Road due to an old concrete pipe from the 50's and DPW supervised and made sure they crossed it cleanly. Alan Lane will be approached to hopefully obtain more interested residents

One resident on Randolph Avenue had a failing septic system. Randolph Health came out and when RVRSA received all the paper work the executive director emailed the Mayor saying the resident would be hooked up to sewer. The whole process went very smoothly.

A questioned was asked about the status of Gillen Street and replacing the sewer line. The Mayor said no one has shown an interest or provided a quote even after numerous attempts to obtain one and not sure what the reason is. It was discussed that it might relate to the fact that the line is so deep it makes the project much more involved than normal. Mayor Morris will be meeting with the Town Engineer next week to discuss the possibility of DPW completing the work.

MINUTES OF THE MINE HILL TOWNSHIP COUNCIL REGULAR MEETING – July 31, 2014

WHEREAS, the Township of Mine Hill, in the County of Morris, New Jersey (the "Township"), has heretofore authorized the following public improvements and acquisitions: (A) resurfacing of South 1st Street, North 1st Street and other roads; (B) undertaking of various improvements to municipal facilities; and (C) acquisition of various equipment and machinery for the use of the Department of Public Works in, by and for the Township, and appropriated therefor the sum of \$120,000 pursuant to Ordinance No. 12-14 adopted by the Township Council of the Township on May 15, 2014 (the "Prior Ordinance"); and

WHEREAS, the Township Council now finds and determines that the additional sum of \$50,000 is required for such improvements and acquisitions and that such sum is available from the Township's Capital Improvement Fund to pay the additional cost of such improvements and acquisitions,

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mine Hill, in the County of Morris, New Jersey, as follows:

Section 1. The additional sum of \$50,000 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in the Prior Ordinance (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Capital Improvement Fund of the Township, as hereinafter provided. The sum of \$50,000 is hereby appropriated from the Capital Improvement Fund of the Township to the payment of the cost of said purpose. No debt is authorized by this ordinance because funds on hand are available and being appropriated.

Section 2. Said improvements and acquisitions are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements and acquisitions have been and shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 3. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

NEW & OLD BUSINESS

Mayor Morris reported that the Town had a half hour phone conference with the Standard and Poors. They asked 16 questions. Questions such as does the Town have any unreasonable debts, has the Town had any huge losses of industry, etc. It was explained to the representative that the Town does neither budgetary borrowing nor capital borrowing. If the Town does not have the money, it does not spend. The representative from the company seemed impressed. A report will be issued and the Town will received a full copy. A new grade will be given with explanations of why the Town is either upgraded or downgraded. The question was asked how does having a Federal Rating help. It was discussed that if there is a need to borrow the Town will get a lower rate. The rating is a reflection of the management of the Town.

The Community Development Block Grant Program, which is a flexible program that provides communities with resources to address a wide range of unique community development needs, and the new demographics were briefly discussed. It was mentioned that it does not look favorable for the Town. It has to do with income levels and census data on different areas, they put you in economic zones. A grant was applied for to pave Thomastown but the income was too high and the same thing happened with South First Avenue.

Ms. Kanzenbach mentioned she was trying to make contact with someone from MAIN (Morris Automated Information Network) but did not hear back from anyone. There may be legislation to create a district library. County College of Morris has an online catalogue and anyone who has a Morris County Library card can use it. There was also discussion about the need to have someone pick up the books from CCM to bring them to the Mine Hill Library for residents to pick up. The Mayor mentioned we need to look for new volunteers to help with the library. Programs available in other towns were discussed like "Read to a Dog". Various solutions and ideas were discussed like approaching and developing a shared usage with other towns or establishing some type of community involvement relationship with Barnes and Nobles to help with the situation.
