Resolution 036-15 Approval of Solid Waste Contract – Blue Diamond Disposal

WHEREAS, the Township of Mine Hill solicited bids for solid waste materials collection services; and

WHEREAS, the Township Clerk on January 13, 2015, received bids for the furnishing of said services; and

WHEREAS, Blue Diamond Disposal, Inc. submitted the lowest responsible and responsive bid pursuant to the Notice to Bidders for the above-referenced contract; and

WHEREAS, the Township Council wishes to award the solid waste materials collection services contract to Blue Diamond Disposal, Inc. in accordance with its Bid Proposal for Option No. 1 for a term of three (3) years; and

WHEREAS, the Chief Financial Officer of the Township of Mine Hill has certified that funds are available for this purpose.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Mine Hill, in the County of Morris and State of New Jersey, as follows:

- 1. A contract for solid waste materials collection services is hereby awarded to in Blue Diamond Disposal, Inc. in accordance with its Bid Proposal, for Option No. 1, for a term of 3 years for the lump sum price of \$747,000 with the understanding that full solid waste collection services shall be provided to the Board of Education in the same manner as had been provided during the previous collection contract.
- 2. The Mayor and Township Clerk are hereby authorized and directed to execute a contract with Blue Diamond Disposal, Inc. in accordance with its Bid Proposal dated January 13, 2015.
- 3. This Resolution shall take effect immediately.
