WHEREAS, Skin Cancer is the most common form of cancer in the United States, affecting 5 million individuals each year; one in five Americans will develop skin cancer in the course of a lifetime, and one in fifty will develop melanoma, which makes it the most common form of cancer in the United States; and

WHEREAS, the two most common forms of skin cancer are basal cell and squamous cell carcinomas are highly curable; melanoma the third most common form of skin cancer is the deadliest skin cancer and one of the most common cancers for young adults and is on the rise nationwide and worldwide; and

WHEREAS, recent studies indicate sun damage in childhood can lead to skin cancer later in life, it also shows young people are not using proper protection and melanoma will account for more than 80,000 cases of skin cancer in 2015, and

WHEREAS, Melanoma is the most common form of cancer for young adults 25-29 years old and the second most common form of cancer for young people 15-29 years old; Over the past 33 years, more people have been diagnosed with skin cancer than ALL other cancer combined; and

WHEREAS, more women are diagnosed with melanoma before the age of 45, by age 60, the rate is more than two times higher in men, and by age 80, the rate in men in nearly three times higher than in women. Melanoma rates are 24 times higher in white people than black people; and

WHEREAS, the overall death rates from all cancers has decreased in the last three years, the incidence of all cancers continues to increase by over 4% with a rise in melanomas of the skin, especially in Morris and Somerset County; and

WHEREAS, rates of sunburn remain high, affecting nearly 37 percent of Americans each year as a result of overexposure to UV rays Indoor tanning is especially dangerous, resulting in an estimated 400,000 cases of skin cancer in the US each year; and

WHEREAS, skin cancer is a serious public health concern, the regional chronic disease coalition of Morris and Somerset and its partners are promoting skin cancer awareness month, everyone especially young people are encouraged to take advantage of skin cancer prevention and early detection opportunities and activities throughout the counties all year long with a focus on having "safe fun in the sun" and outdoors without compromising skin health.

WHEREAS, the RVRSA, by Resolution 15-008, declared a breach in the 1987 agreement between the RVRSA and the Township of Mine Hill (hereinafter "the Agreement") based on an alleged failure of Mine Hill to comply with provisions of the Agreement pertaining to metering; and

WHEREAS, the RVRSA, in declaring this breach, is basing its claim on a provision of the Agreement which it has not enforced in over twenty five years; and

WHEREAS, the RVRSA participated in the design and execution of the construction of the Jackson Brook Interceptor and their engineers were well aware of the alternating design of connections from Mine Hill, Dover and Randolph making single meter metering completely impractical; and

WHEREAS, correspondence from RVRSA attorney Joseph J. Maraziti, Jr. to the attorney representing Mine Hill, dated February 18, 1987 (a copy of which is attached hereto), specifically stated that Mine Hill's flow would not be determined by meter; and

WHEREAS, subsequent amendments to the Agreement failed to make any changes to the metering requirement or the position established in the February 18, 1987 correspondence from Mr. Maraziti; and

WHEREAS, the attempt by the RVRSA to enforce a provision of an agreement it has ignored for over twenty five years is patently unfair and inconsistent with the previous position of the RVRSA and the Township respectfully disagrees that it has breached its agreement with the RVRSA.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Mine Hill, in the County of Morris and State of New Jersey that, while Mine Hill wishes to work with the RVRSA to resolve all outstanding issues including metering, it adamantly disagrees with the content and objects to declaration of breach contain in RVRSA Resolution 15-008; and

WHEREAS, the Morris County Planning Board is currently preparing the Wastewater Management Plan ("WMP") for Morris County municipalities which are not within the Highlands Region including the Township of Mine Hill; and

WHEREAS, the WMP for Morris County includes the Rockaway Valley Regional Sewerage Authority (RVRSA) and establishes the existing and future sewer service area and capacity demands for the RVRSA which includes the Township of Mine Hill; and

WHEREAS, the Township of Mine Hill was included in a Federal grant the RVRSA obtained for design and construction and by agreement dated July 7, 1987, has continuously allowed sewage flow generated in Mine Hill to be treated through the RVRSA system; and

WHEREAS, in 2012 the RVRSA adopted Resolution No. 12-065 consenting to provide sewer service in the future to those areas designated as within the Rockaway Valley Regional Sewerage Authority Wastewater Service Area as depicted on a map entitled "Future Wastewater Service Area map for Morris County amending the following Areawide Water Quality management Plans: Northeast, Upper Delaware, Upper Raritan, Sussex, Date of Current Submittal: March 14, 2012"; and

WHEREAS, it came to the attention of Mine Hill that portions of the Township were not included within the RVRSA future wastewater service area; and

WHEREAS, Mine Hill, consequently, brought this issue to the NJDEP, the County of Morris, and the RVRSA, and requested that the RVRSA wastewater service area be revised to include additional portions of Mine Hill; and

WHEREAS, the NJDEP has determined that these additional areas in Mine Hill should be included in a revised future wastewater service area as set forth on a map entitled "Mine Hill Township NJDEP Revised Future Wastewater Service Area"; and

WHEREAS, the RVRSA adopted Resolution No. 15-009 which purported to consent to the NJDEP approved revision of the Mine Hill portion of the wastewater service area, but proceeded to condition its consent on terms which would discriminate against Mine Hill in contravention of the Federal Grant Agreement as well as conditions which have no bearing on the inclusion of Mine Hill within the wastewater service area; and

WHEREAS, it is important for Mine Hill to memorialize its disagreement with certain conditions set forth in Resolution No. 15-009 and clarify that it in no way has agreed to the imposition of these conditions which in some cases are directly in conflict with its agreement with the RVRSA and its participation in the Federal Grant; and

WHEREAS, it is the opinion of the Mayor and Township Council of the Township of Mine Hill that the Federal grant agreements prevent the RVRSA from discriminating between its "member municipalities" and Mine Hill Township and this attempt to legitimize such discrimination when determining future needs is unacceptable.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Mine Hill, in the County of Morris and State of New Jersey, that Mine Hill specifically rejects the following conditions in the Consenting Resolution:

- 1. Mine Hill specifically objects to the RVRSA conditioning the approval of the revised service area on the expansion of the RVRSA sewage treatment plant capacity or related plan approval by the NJDEP.
- 2. Mine Hill objects to the attempt by the RVRSA to condition its consent on the NJDEP making policy or rule making changes sought by the RVRSA but having nothing to do with the Water Quality Management Planning process and specifically the adoption of the revised WMP area.
- 3. Mine Hill adamantly disagrees with the conditions in the Resolution which indicate that the future sewerage needs of Mine Hill are relegated to a secondary status behind the perceived future needs of "member municipalities".
- 4. Mine Hill objects to any attempt by the RVRSA to impose fees, charges, or metering requirements upon Mine Hill which are different from those imposed upon "member municipalities" as a condition of consent to the NJDEP determination of service area expansion.

BE IT FURTHER RESOLVED, that the Township of Mine Hill does not accept the conditions set forth in the RVRSA Resolution No. 15-009 and urges the NJDEP and the County of Morris to unconditionally approve of the revised future wastewater service area for Mine Hill Township as set forth on the map entitled "Mine Hill Township NJDEP Revised Future Wastewater Service Area" because there is no dispute that this area geographically belongs in the Service Area.

The Township Clerk shall forward a certified copy of this Resolution to the County of Morris, the Morris County Planning Board, the RVRSA and all member municipalities, and the NJDEP.

He recently had the poster of the game board made.

Mr. Morris noted that excavation on the new Memorial will begin next week, and that the monuments will be moved after Memorial Day.
