

Notice to Bidders

Notice is hereby given that sealed proposals will be received by the Township of Mine Hill, Morris County, New Jersey for the "2025 Roadway Resurfacing Program". The bid opening will be held on Tuesday, August 19, 2025, at 11:30 a.m. at the Mine Hill Township Municipal Building, 10 Baker Street, Mine Hill, NJ 07803.

The base bid consists of milling and paving of various municipal streets in Mine Hill Township.

All work on the base bid must be completed within thirty (30) calendar days from the start date indicated in the Notice to Proceed.

Contract documents and drawings for the proposed work (the "Contract Documents", which have been prepared by Paul M. Sterbenz, P.E., PP, of the firm Colliers Engineering & Design Inc. (DBA Maser Consulting), are available electronically or via delivery by common carrier by making a request to diane.kohaut@collierseng.com.

Bidders will be furnished with a copy of the Contract Documents by request upon proper notice to the above e-mail address. In the e-mail message, the contractor shall indicate if they request an electronic copy (PDF format) or paper copy. Electronic copies will be provided via e-mail at no charge. A paper copy of the contract documents will be furnished following receipt of a \$75.00. check to "Colliers Engineering & Design".

The Contract Documents will be available during business hours beginning on Monday, August 4, 2025, at 12:00 PM.

Proposals must be made on the standard Proposal forms in the manner designated in the Contract documents, must be enclosed in sealed envelopes bearing the name and address of the Bidder and the name of the project on the outside and be addressed to Township of Mine Hill and must be accompanied by a Statement of Consent of Surety from a surety company authorized to do business in the State of New Jersey and acceptable to the municipality and either a Bid Bond or a Certified Check drawn to the order of "Township of Mine Hill" for not less than ten percent (10%) of the amount bid, except that the check shall not exceed \$20,000.00. The successful bidder is hereby notified that a performance bond for the full amount of this project is required.

The award of the Contract for this project will not be made until the necessary funds have been provided by the Township of Mine Hill in a lawful manner.

The Township or the Engineer reserves the right to require a complete financial and experience statement from prospective bidders showing that they have satisfactorily completed work of the nature required before furnishing proposal forms or specifications, or before awarding the Contract.

Proposals for this Contract will only be accepted from bidders who have properly qualified in accordance with the requirements of the Contract documents.

The right is also reserved to reject any or all bids or to waive any informalities where such informality is not detrimental to the best interest of the Township. Further, the Township reserves the right to abandon the project and reject the bids entirely if any legal or state or federal administrative action is taken against the Township which could delay or jeopardize the project from commencing. The right is also reserved to increase or decrease the quantities specified in the manner designated in the Specifications.

The successful bidder shall be required to comply with the following:

- A. Affirmative Action requirements (P.L. 1975, C.127, N.J.S.A. 10:5-1 et seq.).
- B. The provisions of the New Jersey Prevailing Wage Act (N.J.S.A. 34:11-56.25 et seq.).
- C. Anti-Kickback Regulations under Section 2 of the Act of June 13, 1934, known as the Copeland Act.
- D. Worker and Community Right-to-Know Act (N.J.S.A. 34:5A-1).
- E. Anti-Drug/Alcohol plan in accordance with 49 CFR Parts 40, 199 and 391.

The bid must also be accompanied by a list of names and addresses of all stockholders owning 10% or more of the stock in accordance with the provisions of the Public Disclosure Law (P.L. 1988, C.33, N.J.S.A. 52:25-24.2).
