Mine Hill Township ORDINANCE NO. 10-2025 PUBLIC NOTICE is hereby given that the following Ordinance was submitted in writing, introduced, read by title and passed on first reading at a meeting of the Township Council of Mine Hill Township, in the County of Morris and State of New Jersey, held on Thursday, July 17, 2025, and will be further considered for final passage on Thursday, August 7, 2025 at 7:00 P.M. at a meeting at the Municipal Building in said Township, or at any time and place to which said meeting may be adjourned, at which time and place a public hearing will be held thereon by the Governing Body and all persons and citizens in interest shall have an opportunity to be heard concerning said Ordinance. Copies of said Ordinance are available at the office of the Township Clerk during regular office hours. BY ORDER OF THE TOWNSHIP COUNCIL Marcia H. Istvan, RMC, Township Clerk AN ORDINANCE AMENDING CHAPTER 425 OF THE REVISED GENERAL ORDINANCES OF MINE HILL TOWNSHIP AND AMENDING THE FEE FOR SEWER SYSTEM CONNECTIONS BE IT ORDAINED, by the Township Council of Mine Hill Township, in the County of Morris, and State of New Jersey, as follows: Section 1. Chapter 425, Section 425-38, "Connection and Tapping Fees", Subsection A "Connection Fee" is hereby amended to read in its entirety as follows: "A. Connection fee. (1) The owner or occupant of a unit who desires or is required to connect said unit to a Township sanitary sewer line for the purpose of the discharge of human and/or processed waste (including only those wastes acceptable pursuant to these regulations or other acceptable requirements of the state, federal or local governments) shall pay a connection fee. (2) The connection fee payable to Mine Hill Township Sewer Utility shall be \$7,720.00 per Equivalent Dwelling Unit (EDU). (3) The capital contribution fee due to the Rockaway Valley Regional Sewage Authority (RVRSA) will be collected and remitted to them. This fee is set by them, subject to change, and will be on file with the Township. (4) The RVRSA permit fee is to be made out to the RVRSA and submitted along with their permit application. This fee is set by them, subject to change, and will be on file with the Township. Section 2. This Ordinance may be renumbered for codification purposes. Section 3. All Ordinances of Mine Hill Township which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency. Section 4. If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance. Section 5. This Ordinance shall take effect upon final publication and in accordance with law. P.F.\$58.14 07/24/T1
