Mine Hill Township ORDINANCE NO. 12-2025 PUBLIC NOTICE is hereby given that the following Ordinance was submitted in writing, introduced, read by title and passed on first reading at a meeting of the Township Council of Mine Hill Township, in the County of Morris and State of New Jersey, held on Thursday, September 18, 2025, and will be further considered for final passage on Thursday, October 2, 2025 at 7:00 P.M. at a meeting at the Municipal Building in said Township, or at any time and place to which said meeting may be adjourned, at which time and place a public hearing will be held thereon by the Governing Body and all persons and citizens in interest shall have an opportunity to be heard concerning said Ordinance. Copies of said Ordinance are available at the office of the Township Clerk during regular office hours. BY ORDER OF THE TOWNSHIP COUNCIL Marcia H. Istvan, RMC, Township Clerk AN ORDINANCE TO AMEND CHAPTER 380 OF THE REVISED GENERAL ORDINANCES OF MINE HILL TOWNSHIP BE IT ORDAINED, by the Township Council of Mine Hill Township, in the County of Morris, and State of New Jersey, as follows: SECTION 1. Chapter 380 of the Revised General Ordinances of Mine Hill Township, entitled "Do Not Solicit List", Section 380-2, shall be amended to read, in its entirety, as follows: 380-2 Registration Required A. It shall be unlawful to solicit within Mine Hill Township without first registering with the Township Clerk on a form to be provided by the Township Clerk which shall indicate the identification of the individual or individuals soliciting, the planned date or dates, time, and place where the solicitation will occur. A copy of the "Do Not Solicit List" shall be provided to every person registering with the Township Clerk. Anyone engaged in solicitation shall have proof of registration and shall have personal identification outwardly visible on their person at all times while soliciting in Mine Hill. Solicitation shall be permitted between the hours of 10:00 a.m. to sunset except in May, June, July and August when it shall end by 8:00 p.m. B. Any person registering with the Township Clerk shall file with an application to be supplied by the Clerk containing the following information: (1) Name and permanent address of applicant. (2) Date of birth, weight, height, hair color, eye color (3) Car make, model, license number and car registration number of any vehicle being used in conjunction with the solicitation. (4) Name and address of employer. (5) Type of merchandise or service to be sold. (6) At least three business and character references. (7) The residence of applicant for the preceding three years. (8) The length of time for which license is desired. (9) The number of arrests or convictions for misdemeanors, crimes or disorderly conduct, and when and where the offenses occurred. C. If the applicant is an employee or agent, he or she must attach to the application form a letter from the firm or corporation for which the applicant purports to work, authorizing applicant to act as its agent or representative. D. Investigation. When application is properly filled out and signed by the applicant, it shall be the duty of the Township Clerk to refer the same to the Chief of Police who shall investigate the accuracy of statements made therein and not more than three days shall be

allowed for such investigation. After investigation, the Clerk and the Chief of Police shall indicate approval or disapproval in writing upon the application. In case of disapproval of an application, the applicant may appeal to the Mayor and Council. The Mayor and Council shall set a time and place for a hearing, which hearing shall be held within 10 days after appeal is taken by applicant, at which hearing applicant will be given an opportunity to present his reasons why the license should be issued. The decision of the Mayor and Council shall be final. E. Fees. There shall be a registration fee of \$25.00 which shall be good for a period of 30 days. The fee will be waived for solicitation by nonprofits and their agents. SECTION 2. This Ordinance may be renumbered for codification purposes. SECTION 3. All Ordinances of Mine Hill Township which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency. SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance. SECTION 5. This Ordinance shall take effect as required by law. P.F.\$89.76 09/25/T1
