Istvan, RMC, Township Clerk ORDINANCE REPEALING CHAPTER 514 OF THE REVISED GENERAL ORDINANCES OF MINE HILL TOWNSHIP REQUIRING ANNUAL LICENSES FOR USED MOTOR VEHICLE DEALERS BE IT ORDAINED, by the Township Council of Mine Hill Township, in the County of Morris, and State of New Jersey, as follows: Section 1. Chapter 514 of the Revised General Ordinances of Mine Hill Township entitled "Used Motor Vehicle Dealers" shall be repealed in its entirety. Section 2. All Ordinances of Mine Hill Township which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency. Section 3. If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.
