**CAPITAL ORDINANCE AUTHORIZING VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS
IN, BY AND FOR THE TOWNSHIP, APPROPRIATING THEREFOR THE SUM OF \$150,014.60
AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM
THE CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP**

BE IT ORDAINED by the Township Council of Mine Hill Township, in the County of Morris, New Jersey, as follows:

Section 1. Mine Hill Township, in the County of Morris, New Jersey (the "Township") is hereby authorized to undertake the following in, by and for the Township:

- (A) Improvements to municipal facilities including: civic center air conditioning; town hall generator;
- (B) Improvements to parks including a pavilion for Memorial Park;
- (C) Curb repairs/installations on Scrub Oaks Road, Thomastown Road & Oakwood Avenue, and Howard Avenue & Frank Street; and
- (D) Paving of Baker Street & Howard Avenue

Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$150,014.60 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Capital Improvement Fund of the Township. The sum of \$150,014.60 is hereby appropriated from the Capital Improvement Fund of the Township to the payment of the cost of said purpose. No debt is authorized by this ordinance because funds on hand are available and being appropriated.

Section 3. Said improvements are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefitted.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
